Terms And Conditions

- 1. The Party shall clearly mention the make / Brand of the offered work bench. Make/brands as specified in the tender only will be accepted. Offers with other makes/brands will be rejected.
- 2. The Party shall furnish the authorisation certificate from Original Equipment Manufacturer(OEM) for the offered work bench.
- 3. Manufacturer/ Authorised dealer should provide proof (copies of Purchase orders, Invoices etc.) of supply of similar work bench of cost 10 lakhs or more, made using equivalent make of components or parts, by them in the last 3 years period to Govt. Organisations, R&D organisations, Public sector companies or leading private sector companies.
- 4. The Party shall furnish the catalogue/brochure data sheet of all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications)
- 5. The Party shall clearly mention the Make, specifications and numerical values (wherever required) of the work bench and all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) against each specification in the compliance matrix along with datasheet / catalogue/brochure. Make/brands as specified in the tender only will be accepted. Offers with other makes/brands will be rejected. Comments such as mere Yes, agreed, etc are not acceptable and Compliance matrix prepared with such comments will be considered incomplete.
- 6. Detailed compliance matrix for the specifications of the work bench & instrumentation and control systems (sl nos 1 to 12) and Terms and conditions mentioned in Annexure shall be furnished along with the offer
- 7. The manufacturer shall have inbuilt facility of NABL accredited lab for calibration and service maintenance lab for the maintenance/ service support of the instrumentation and controls of the work bench in India.
- 8. The work bench along with all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) shall have warranty period of 5 years.

- 9. NABL accredited calibration certificate for all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) to be supplied along with the item.
- 10. The party shall carry out the calibration of all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) every year for next five years free of cost.
- 11.Readiness and prove out of the unit to be intimated well in advance for carrying out the Pre delivery Inspection of the work bench at Party's site.
- 12. The Party shall supply, install, commission and successfully demonstrate the functioning of all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) at VSSC. All the tools and instruments required for the same shall be brought by the Party
- 13. Training shall be imparted to the VSSC personnel for the operation and maintenance of all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications)
- 14.All the required documents (Both Hard and Soft copies) of all the instrumentation and control units of the work bench (sl nos 1 to 12 of the specifications) shall be supplied along with the work bench.
- 15.Detailed compliance matrix for the specifications of the work bench & instrumentation and control systems (sl nos 1 to 12) satisfying all the terms and conditions as mentioned only will be considered for evaluation. Incomplete compliance matrix or partially filled compliance matrix will be rejected. Such offers will not be considered for evaluation.
