Vendor with overall lowest overall price shall be considered financial L1 bidder.

## **3. Overall Evaluation criteria**

All the technical compliant vendors having compliance with Points mentioned in Part 1 (Technical Evaluation Criteria) shall be considered for Financial Evaluation and based on overall price he/she shall be considered as overall L1 bidder
