- 3. The Tenderers are requested to update their address and contact details, if necessary and submit the Bids online at least two days prior to closing date to avoid last minute system / network related problems. - 10. Applicable Law: The Contract shall be governed by Indian Law for the time being in force and jurisdiction shall lie in the Courts of India.

Subject to provisions of this clause, the courts at Bangalore shall have exclusive jurisdiction. Performance under this Contract shall, however continue during Arbitration proceeding and no payment due or payable by the parties hereto shall be withheld unless any such payment is/or forms a part of the subject matter of the Arbitration proceedings.
- 16. Force Majeure: Neither party shall bear responsibility for the complete or partial non-performance of any of his obligations if the non-performance results from such force majeure circumstances such as, but not restricted to, flood, fire, earthquake, civil commotion, sabotage, explosion, epidemic, quarantine restriction, strike, lock-out, freight embargo, acts of the Government, acts of public enemy and other acts of God as well as war or revolution, military operation, blockade, acts or actions of State authorities or any other circumstance beyond the control of the parties provided the other party is notified in writing within 21 days from the date of commencement of the unforeseeable event.
